ABOUT THIS SCHOLARSHIP

We have the pleasure of announcing the 2018 College Dream Fund Scholarship. The College Dream Fund is a scholarship program founded in 2010 by a group of community leaders and led by Dr. Jim Young to help undocumented students. This year, Youth 2 Leaders will continue the great work that the College Dream Fund has done for deserving students in Kern County. Students must be planning to attend in Fall 2018 and carry a minimum of 12 semester units or 9 quarter units. This year, approximately 20-30 scholarships will be awarded. All students who have or will graduate from a Kern County High School are welcome to apply. The amount of the scholarship is \$500 per academic year, and will be based on the students UNMET NEED as determined by their Financial Aid Office of the school that they will be attending in the 2018/2019 academic year, so it is crucial for applicants to file their FAFSA by the March 2nd priority deadline. We strongly encourage that all students, regardless of financial need, apply. Scholarship recipients will be announced during the month of April 2018.

ELIGIBILITY REQUIREMENTS

- Must have graduated or be graduating from a Kern County High School
- Must demonstrate financial need
- Must have a minimum GPA of 2.0
- Must be working on, or planning to work on an Undergraduate Degree
- Must be attending a Community College, College or University

- Please mail the following documents in **one, complete application packet** (no paperclips or staples, name at the top of every page):
 - **Scholarship Application**-Make sure your entire application packet is complete and legible. Incomplete or illegible applications will not be considered.
 - **Personal Statement**- No more than two pages, typed, double spaced, 12 point font, Times or Ariel font.
 - Current, **Unofficial Transcript** with cumulative GPA
 - Copy of the **Student Aid Report** (SAR) from the FAFSA, if available.
 - If you are an AB540 student, please submit the California Aid Report (CAR) at the end of your CA Dream Act Application. A copy of the CAR be found online at <https://dream.csac.ca.gov/> and accessed by logging into the student's account.
 - The SAR or CAR must include the Estimated Family Contribution (EFC).
 - A copy of the SAR can be found online at www.fafsa.ed.gov and accessed by logging into the student's FAFSA account.
 - **Two Letters of Recommendation**- Letters should be sealed in envelopes and signed by the letter writer before being included in the packet to ensure security.

Scholarships will be awarded based on a comprehensive evaluation considering your academic potential, personal background (i.e. program participation, low-income, first generation, extracurricular activities, etc.) and official Letters of Recommendation. If awarded, recipients will need to submit a copy of their official Financial Aid Award Package, Fall 2018 college/university course schedule, preliminary academic plan, and other documents as requested.

Letters of Recommendation

To complete this application you must include two letters of recommendation. At least one of these letters must be from a school official (teacher, counselor, etc.). The second letter may be from a school official, employer, volunteer supervisor, religious leader, etc. but may NOT be from a family member. Expected topics of discussion are character, dedication or work ethic, and why they believe you will succeed in college. Note: These letters will be scored individually and must be official. No generic letters please.

Consent Form

By signing and submitting this form, I authorize YOUTH 2 LEADERS EDUCATION FOUNDATION to share all information held by YOUTH 2 LEADERS EDUCATION FOUNDATION relating to me, including all information I provide in my application including, but not limited to, personal information, such as my name, mailing address, email address and date of birth, and information relating to any financial aid awarded to me and my attendance at any higher education institution (together, my "Personal Information"), with the College Access Foundation of California (CAFC) for the purpose of researching and evaluating scholarships and programs, and to better enable young people to attend college and university.
